Neighborhood Update

How Providence's \$50 million bond issue has been and will be spent is a big concern of residents city-wide. Many on the City Council, Councilman Kevin Jackson included, have tackled it in phases. The first phase was street repaving. The cost estimate for third ward streets repaved this fall was about \$535,000. In addition, the Journal recently reported that \$150,000 was approved for improvements to parks, including Billy Taylor Park, Collyer Field and Lippitt Park.

With most of the ward's \$2.1 million share still unspent, there is still strong support among neighbors to invest a portion of the money so that improvements can continue into future years.

In other news, the fate of the former **Jewish Home** on Hillside Avenue remains unresolved as two appeals move slowly through the courts. One was a zoning decision that went against neighbors and the other was a Health Department decision that went against the developer.

Business Scene

Call it the Hope Street shuffle. Three businesses have followed Eden Park Cleaners' lead and moved to new digs on the street. Atomic Comics moved south to the space vacated by Hope Street Attic, next to Lad & Lassie Shoes. The Gallery Cafe moved from the Pawtucket line to the former location of Eden Park, next to Fleet Bank. And Union Watch and Clock has moved behind Podrat Coin.

New to the street is **The Lower East Side Deli and Market**, taking over for the venerable Miller's Delicatessen. Kosher prepared foods are among their specialities.

Nature's Remedies has moved into 727 Hope Street, formerly Tikva. They offer herbs, teas and a variety of alternative health products.
